本聲明內提及的投票日期是指根據《行政長官選舉條例》(第 569 章)第 23 或 24 條進行的投票。就有競逐的選舉而言，是指首三輪投票的日期。根據《選舉程序(行政長官選舉)規例》(第 541 章, 附屬法例 J)第 17(3)條，在有競逐的選舉中，如須進行第四輪或其後任何一輪投票，便會於翌日進行，如有需要，則日復一日地進行，直至有候選人當選為止。此聲明適用於任何一輪投票。

The polling date referred to in this declaration is for a poll conducted under section 23 or 24 of the Chief Executive Election Ordinance (Cap. 569). For a contested election, the polling date is for the first three rounds of voting. In accordance with section 17(3) of the Electoral Procedure (Chief Executive Election) Regulation (Cap. 541 sub. leg. J), if in a contested election the voting has to proceed to the fourth or any subsequent round, it will be held on the following day and, if necessary, day after day thereafter until a candidate is returned. This declaration is applicable to any round of voting.
