1. 每份提名表格只能提名一份候選人名單。

If for any reason a subscriber is found to be ineligible, his name will be disregarded.

A nomination form must be handed in by one of the candidates on the nomination list in person and received by the Returning Officer within the nomination period from 19 July 2008 to 1 August 2008 during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. The nomination form should be accompanied by-

- (a) 選舉按金港幣 50,000 元，以現金或劃線支票／銀行本票（抬頭請寫「香港特別行政區政府」）支付〔為避免因支票遭銀行退票而令提名失效，候選人如在 2008 年 7 月 30 日或之後遞交提名表格，應盡量以現金或銀行本票支付選舉按金〕；及

an election deposit in the sum of HK\$50,000 in cash; or by crossed cheque/cashier order made payable to “The Government of the Hong Kong Special Administrative Region” **(in order to avoid the risk of invalidation of the nomination due to dishonoured cheque, candidates are strongly advised to submit the election deposit in cash or cashier order if they submit the nomination form on or after 30 July 2008)**; and

- (b) 提名名單上每名候選人根據《立法會條例》（第 542 章）第 40(1)(b)(iii)條作出的採用承諾形式的誓言（已附夾在提名表格內）；

（採用承諾形式的誓言必須在一位監督員、公證人、太平紳士或持有執業證書的律師面前作出。）

a promissory oath by each candidate on a nomination list to the effect as required in section 40(1)(b)(iii) of the Legislative Council Ordinance (Cap. 542) (has already been attached to the Nomination Form).

(The promissory oath has to be made before a Commissioner for Oaths, a Notary Public, a Justice of the Peace or a solicitor holding a practising certificate.)

候選人請留意，提名表格必須載有上述採用承諾形式的誓言。

Candidate(s) should note that the nomination form must contain the promissory oath for the purpose of nomination.

10. 準候選人應盡早遞交提名表格，以便於提名期結束前，將提名表格上可能發現的錯處更正。

Prospective candidate(s) is/are strongly advised to submit his/their nomination form as early as practicable so that any mistakes found in the nomination form can be rectified before the close of nominations.

11. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。

The Returning Officer may not accept any nomination form on which the name(s) or other important particulars of the candidate(s) has/have been amended, altered or corrected.

12. 一般而言，除非選舉主任決定提名無效，否則獲提名的候選人即作為正式獲提名論，並可展開選舉活動。選舉主任所作的決定，將為最終決定，除以選舉呈請書提出質疑外，不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides otherwise, candidate(s) on a nomination list is/are deemed to stand nominated and he/they may hence carry out activities to promote his/their election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

13. 提名表格必須按《立法會條例》（第 542 章）及《選舉管理委員會（選舉程序）（立法會）規例》（第 541 章，附屬法例 D）的規定列載所需的資料，方才有效。在決定候選人是否合乎資格及提名表格有效與否時，選舉主任可要求候選人提供其認為需要的額外資料。

A nomination will not be valid unless it contains the information as required by the Legislative Council Ordinance (Cap. 542) and the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541 sub. leg. D). The Returning Officer concerned may request such additional information from a candidate or candidates as he considers necessary to satisfy himself as to the eligibility of the candidate(s) and the validity of the nomination.

14. 候選人不得在 2008 年的立法會選舉中在超過一個地方選區或功能界別接受提名。候選人遞交提名表格時，必須已退出在所有其他選區或界別的選舉，否則，他新提交的提名將會當作無效。

A candidate cannot be nominated for more than one geographical or functional constituency in the 2008 Legislative Council Election. When he hands in his nomination form, he must have withdrawn his candidature in respect of all other constituencies, if any, or else his new nomination will be held to be invalid.

15. 候選人如欲退出選舉，可填寫一份指定的「候選人退選通知書」，最遲於提名期結束前交回有關的選舉主任。

If a candidate wishes to withdraw his candidature, he may do so by completing and delivering to the Returning Officer concerned a Notice of Withdrawal of Candidature in a specified form before the close of nominations.

16. 本提名表格第二部分必須於見證人在場下由各名候選人填寫及簽署。任何年滿 18 歲並持有香港身分證的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。

Part II of this form should be completed and signed by each of the candidate(s) in the presence of a witness who can be any person who is in possession of a Hong Kong Identity Card and aged 18 years or over. The witness is required to complete Part III of this form and sign thereunder.

Qualifications and disqualifications for nomination as a candidate or election as a Member are dealt with in sections 37(1), 38, 39, 40 and 41 of the Legislative Council Ordinance (Cap. 542) which are reproduced below for reference-

獲提名為地方選區候選人的資格（《立法會條例》（第 542 章）第 37(1)條）

- (1) 符合以下條件的人方有資格在地方選區的選舉中獲提名為候選人—
- (a) 年滿 21 歲；及
 - (b) 已登記為地方選區的選民並有資格如此登記；及
 - (c) 並未有憑藉第 39 條或任何其他法律喪失獲選為議員的資格；及
 - (d) 在緊接提名前的 3 年內通常在香港居住；及
 - (e) 是香港永久性居民中的中國公民，並且沒有中華人民共和國以外的國家的居留權。

Who is eligible to be nominated as a candidate of a Geographical Constituency (section 37(1) of the Legislative Council Ordinance (Cap. 542))

- (1) A person is eligible to be nominated as a candidate at an election for a geographical constituency only if the person –
 - (a) has reached 21 years of age; and
 - (b) is both registered and eligible to be registered as an elector for a geographical constituency; and
 - (c) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
 - (d) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
 - (e) is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.

- (1) 在本條中—

“獲提名人” (nominee) 指姓名被列入提名名單內作為候選人的。
- (2) 在地方選區參加議員選舉的候選人的提名，須採用向選舉主任呈交名單的方式作出，該名單須載有一—

- (3) 提名名單必須—

 - (c) 載有根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例所規定的任何其他詳情。
- (4) 如為某組合呈交的提名名單載有多於一名人士的姓名，則該等姓名必須按該組合中的人士的優先次序排列。
- (4A) 在提名名單呈交選舉主任後—
 - (a) 名列於該名單的獲提名人的姓名次序不能改動；
 - (b) 不能將其他人的姓名加入該名單；及
 - (c) 已在該名單內的人的姓名亦不能刪除。
- (5) 選舉主任必須裁定提名名單上的每名獲提名人是否獲有效提名。
- (6) 如一—
 - (a) 選舉主任裁定任何獲提名人不獲有效提名；
 - (b) 任何獲提名人的提名被撤回；或
 - (c) 任何獲提名人去世，

則選舉主任必須自提名名單剔除該獲提名人的姓名，而名列該名單的獲提名人的姓名的優先次序亦須據此調整。
- (6A) 選舉主任在裁定某獲提名人是獲有效提名之後，如在提名期結束之前接獲證明並信納該人已去世或喪失獲提名資格，選舉主任必須自提名名單剔除該人的姓名，並據此調整名列該名單的獲提名人的姓名的優先次序。
- (7) 如按照第(6)或(6A)款將獲提名人的姓名從提名名單上作出剔除後，該名單上再無任何姓名，則選舉主任必須拒絕接納該名單。
- (8) (重編為第(4A)款)
- (9) 如在提名期結束後，仍在提名名單上的獲提名人的人數多於有關選區須選出的議員的人數，則選舉主任須顧及該等獲提名人於該名單上的排列次序，而將多出的獲提名人的姓名從名單上除去，使仍在該名單上的獲提名人的人數與該選區須選出的議員的人數相同。
- (10) 選舉主任在根據第(6)、(6A)及(9)款剔除獲提名人的姓名後，仍在提名名單上的獲提名人須按其姓名列於該名單上的同一優先次序排列（如有多於一名所餘獲提名人），而為第 49 條的目的，該名單即視作為候選人名單。
- (11) 如在選舉日期之前，選舉主任接獲證明並信納任何名列某候選人名單的候選人已去世或喪失獲提名為候選人的資格，選舉主任必須自該名單剔除該候選人的姓名。
- (12) 選舉主任在根據第(11)款自某候選人名單剔除任何姓名後，不得將任何其他人的姓名加入該名單內。

- (13) 如在採取第(11)款所提述的行動後，候選人名單上再無任何姓名，則選舉主任必須拒絕接納該名單。
- (14) 在選舉主任採取第(11)款所提述的行動後仍在候選人名單上的候選人，為第 49 條的目的，即視作為組成新的候選人名單，以取代根據第(10)款組成的名單。

Nomination lists for geographical constituencies (section 38 of the Legislative Council Ordinance (Cap. 542))

- (1) In this section -
“nominee” (獲提名人) means a person whose name is included in a nomination list as a candidate.
- (2) The nomination of candidates for election as Members for a geographical constituency is to be by a list submitted to the Returning Officer containing either -
 - (a) the names of 2 or more persons contesting the election for that geographical constituency as a group;
or
 - (b) the name of a person contesting that election as a single candidate.
- (3) A nomination list must -
 - (a) be submitted -
 - (i) on a nomination form that complies with regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
 - (ii) by a nominee on the nomination list concerned;
 - (iii) within the nomination period; and
 - (iv) in the manner prescribed by those regulations; and
 - (b) be accompanied by the written consent, made on the nomination form, of each nominee on the nomination list; and
 - (c) contain any other particulars required by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541).
- (4) If a nomination list contains the names of 2 or more persons, the names are to be ranked in the order of priority of the group for which the nomination list is submitted.
- (4A) After a nomination list has been submitted to a Returning Officer -
 - (a) the order in which names of nominees appear in the list cannot be altered;
 - (b) the names of other persons cannot be added to the list; and
 - (c) the names of persons already on the list cannot be deleted.
- (5) The Returning Officer must determine, for each nominee whose name appears on the nomination list, whether or not the nominee is validly nominated.
- (6) If -
 - (a) the Returning Officer determines that a nominee is not validly nominated; or
 - (b) a nominee’s nomination is withdrawn; or
 - (c) a nominee dies,that Officer must strike out the name of that nominee from the nomination list and adjust the order of priority in which the names of nominees appear on that list accordingly.
- (6A) If, after the Returning Officer has determined that a nominee is validly nominated, but before the close of nominations, proof is given to the satisfaction of the Returning Officer that the nominee has died or is disqualified from being nominated, that Officer must strike out the name of that nominee from the nomination list and adjust the order of priority in which the names of nominees appear on that list accordingly.
- (7) If, after striking out names from a nomination list in accordance with subsection (6) or (6A), no name remains on the list, the Returning Officer must reject the list.
- (8) (Renumbered as subsection (4A))
- (9) If, after the close of nominations, the names of more nominees remain on a nomination list than the number of Members to be returned for the constituency concerned, the Returning Officer must, having regard to the order in which the nominees’ names appear on the list, exclude from the list the names of the surplus nominees so that only a number of nominees equal to the number of Members to be returned for the constituency remain on the list.
- (10) The nominees whose names remain on a nomination list after the Returning Officer has taken the action referred to in subsections (6), (6A) and (9) (as arranged in the order of priority indicated on the nomination list if there are 2 or more such remaining nominees) are taken as constituting a list of candidates for the purposes of section 49.
- (11) If, before the date of the election, proof is given to the satisfaction of the Returning Officer that a candidate whose name appears on a list of candidates has died or is disqualified from being nominated as a candidate, the Returning Officer must strike out the name of that candidate from the list.
- (12) After striking out a name from a list of candidates under subsection (11), the Returning Officer must not add the name of any other person to the list.
- (13) If, after taking the action referred to in subsection (11), no name remains on the list of candidates, the Returning Officer must reject the list.

- (14) The candidates whose names remain on a list of candidates after the Returning Officer has taken the action referred to in subsection (11) are taken as constituting a new list of candidates that replaces the one constituted under subsection (10) for the purposes of section 49.

- (1) 任何人如有以下情況，即喪失在選舉中獲提名為候選人的資格及當選為議員的資格—
- (a) 是—
 - (i) 司法人員；或
 - (ii) 訂明的公職人員；或
 - (iii) 立法會的人員或立法會管理委員會的職員；或
 - (b) 已在香港或任何其他地方被判處死刑或監禁（不論如何稱述），但—
 - (i) 既未服該刑罰或主管當局用以替代該項刑罰的其他懲罰；而
 - (ii) 亦未獲赦免；或
 - (c) 已被裁定犯叛逆罪；或
 - (d) 在提名當日或選舉當日正因服刑而受監禁；或
 - (e) 在不局限(b)段的原則下，被裁定或曾被裁定犯以下罪行，而選舉於或將於其被定罪日期後的 5 年內舉行—
 - (i) 任何罪行（不論是在香港或是在任何其他地方被定罪），並就該罪行被判處為期超逾 3 個月而又不得選擇以罰款代替的監禁（不論是否獲得緩刑）；或
 - (ii) 在違反《選舉（舞弊及非法行為）條例》（第 554 章）的情況下作出舞弊或非法行為；或
 - (iii) 《防止賄賂條例》（第 201 章）第 II 部所訂的罪行；或
 - (iv) 根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例所訂明的任何罪行；或
 - (f) 因本條例或任何其他法律的施行而—
 - (i) 無資格在選舉中成為候選人或當選為議員；或
 - (ii) 喪失在選舉中成為候選人或當選為議員的資格；或
 - (g) 是香港以外地方的政府的代表或該政府的受薪政府人員；或
 - (h) 是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；或
 - (i) 是未獲解除破產的人，或於過去 5 年內在沒有向債權人全數償還債務的情況下，獲解除破產或與其債權人訂立《破產條例》（第 6 章）所指的自願安排的人。
- (2) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失在選舉中獲提名為候選人的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有獲提名為候選人的資格。
- (3) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失當選為議員的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有當選為議員的資格。
- (4) 任何人如在提名期結束後已不再與某功能界別有密切聯繫，則該人即喪失當選為該功能界別的議員的資格。
- (5) 在本條中—
- “司法人員” (judicial officer) 指擔任《公務員敘用委員會條例》（第 93 章）第 2 條所界定的司法職位的人；
- “訂明的公職人員” (prescribed public officer) 指—
- (a) 公務員敘用委員會主席；
 - (b) 廉政專員、副廉政專員及擔任在《廉政公署條例》（第 204 章）下的任何其他職位的人；
 - (c) 申訴專員及根據《申訴專員條例》（第 397 章）第 6 條獲委任的人；
 - (d) 選舉管理委員會的成員；
 - (e) 金融管理局的行政總裁及該局的高層管理人員，包括科主管、行政總監、經理及該局僱用的律師；或
 - (ea) 個人資料私隱專員及其根據《個人資料(私隱)條例》（第 486 章）僱用或聘用的人；
 - (eb) 平等機會委員會的主席及由該委員會根據《性別歧視條例》（第 480 章）僱用或聘用的人；
 - (f) 受僱於政府部門或政策局而在該政府部門或政策局任職（不論該職位屬永久性或臨時性的）的人。

When person is disqualified from being nominated as a candidate and from being elected as a Member (section 39 of the Legislative Council Ordinance (Cap. 542))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the person -
 - (a) is -
 - (i) a judicial officer; or
 - (ii) a prescribed public officer; or
 - (iii) an officer of the Legislative Council or a member of staff of The Legislative Council Commission; or
 - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either -
 - (i) served the sentence or undergone such other punishment as a competent authority may have been substituted for the sentence; or
 - (ii) received a free pardon; or
 - (c) has been convicted of treason; or
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted -
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
 - (ii) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
 - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iv) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541); or
 - (f) is -
 - (i) ineligible to be a candidate, or to be elected as a Member, at the election; or
 - (ii) disqualified from being a candidate, or from being elected as a Member, at the election, because of the operation of this or any other law; or
 - (g) is a representative or salaried functionary of a government of a place outside Hong Kong; or
 - (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level; or
 - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is also disqualified from being nominated as a candidate at an election if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection is eligible for nomination as a candidate if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (3) A person is also disqualified from being elected as a Member if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (4) A person is also disqualified from being elected as a Member for a functional constituency if, since the close of nominations, the person has ceased to have a substantial connection with the constituency.
- (5) In this section -

“judicial officer” (司法人員) means the holder of a judicial office, as defined in section 2 of the Public Service Commission Ordinance (Cap. 93);

“prescribed public officer” (訂明的公職人員) means any of the following -

 - (a) the Chairman of the Public Service Commission;
 - (b) the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204);
 - (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397);
 - (d) a member of the Electoral Affairs Commission;
 - (e) the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority;

- (ea) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486);
- (eb) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480);
- (f) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau.

 - (I) 在違反《選舉（舞弊及非法行爲）條例》（第554章）的情況下作出舞弊或非法行爲；或
 - (II) 《防止賄賂條例》（第201章）第II部所訂的罪行；或
 - (III) 根據《選舉管理委員會條例》（第541章）訂立並正有效的規例所訂明的任何罪行；
 - (E) 由於本法例或任何其他法例的實施而喪失在選舉中獲選為議員的資格；
 - (F) 成爲香港以外地方的政府的代表或該政府的受薪政府人員；
 - (G) 成爲香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；
 - (H) 成爲中央人民政府或任何其他國家或地區的武裝部隊的成員；或
 - (I) （如是某功能界別選出的議員）不再與有關功能界別有密切聯繫。
- (2) 該人必須簽署該等聲明。
- (3) 按金須為《規例》為施行本條而訂明的款額。

What requirements are to be complied with by persons nominated as candidates (section 40 of the Legislative Council Ordinance (Cap. 542))

- (1) A person is not validly nominated as a candidate for an election for a constituency unless -
 - (a) a deposit has, in the manner prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541), been lodged by or on behalf of the person with the Returning Officer concerned; and
 - (b) the nomination form includes or is accompanied by -
 - (i) a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region; and
 - (ii) a declaration as to the person's nationality and as to whether or not the person has a right of abode in a country other than the People's Republic of China; and
 - (iii) a promissory oath given by the person to the effect that, if elected, he or she will not do anything during his or her term of office that results in his or her -
 - (A) becoming -
 - (I) a prescribed public officer within the meaning of section 39(5); or
 - (II) an officer of the Legislative Council or a member of staff of The Legislative Council Commission;
 - (B) being sentenced to death in Hong Kong or any other place;
 - (C) being convicted of treason;

- (D) being convicted -
 - (I) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
 - (II) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (III) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
 - (E) being disqualified from being elected as a Member at an election because of the operation of this or any other law;
 - (F) becoming a representative or salaried functionary of a government of a place outside Hong Kong;
 - (G) becoming a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level;
 - (H) becoming a member of the armed forces of the Central People's Government or any other country or territory; or
 - (I) in the case of a Member elected for a functional constituency, ceasing to have a substantial connection with the constituency.
- (2) The person must sign the declarations.
- (3) The deposit is to be of such an amount as is prescribed by the regulations for the purposes of this section.
